- He/She has incurred any disqualification under the Haryana Registration and Regulation of Societies Act, 2012, the Rules framed thereunder, or the Bye-Laws of the Association.

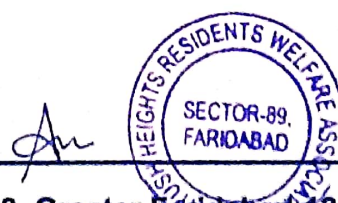
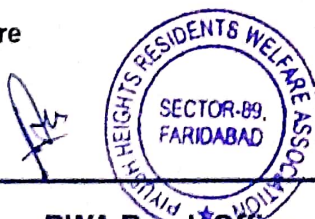
Initial/Provisional List of Members Eligible to Vote

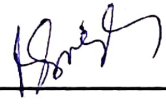
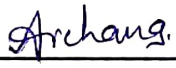
